Assessment of the compliance with the national minimal requirements

The information about publications and other activities presented by assist. prof. Polina Mihova according to the requirements of NACID shows that she meets the minimum national requirements specified in Art. 2b of the ZRASRB for occupying the position of professor in the professional field 7.4. Public Health. It should be noted that the candidate has far more than the required number of points in some groups of indicators.

Research and results

The data presented by the applicant shows intensive and fruitful research activity for over 10 years. The problems studied are mainly in the field of telemedicine, the creation of online learning platforms and interactive therapeutic applications for people with various communication disorders.

The publications abroad as well as the citations from foreign authors make a very good impression.

The main part of the presented materials is the monograph by Polina Mihova entitled "Applied software solutions in healthcare" (Mihova, 2020, Assenevtsi Press). It addresses a central important problem of building information systems in medical practice.

What makes a very good impression is the clear and systematic discussion of existing views and practices which prepares well the presentation of the contribution part of the book. A large part of the book is a serious and deep historiographical study of the problems under consideration, which is a significant contribution by itself. The main contributions are related to the presented author's models of software solutions and implemented developments.
